

AMICUS EXPANDS BRISTOL-MYERS SQUIBB PARTNERSHIP TO HUNGARY

PRESS RELEASE NO. 15: Amicus A.G. and Bristol-Myers Squibb (BMS) have expanded their 2015 Distributorship Agreement by adding the territory of Hungary effective from July 1st, 2017. Under the new arrangement, several current BMS Hungary employees will move to Amicus Hungary.

On June 16th, 2017 Amicus A.G. and Bristol-Myers Squibb signed an addendum to their existing 2015 Distributorship contract, whereby commencing from July 1st 2017 Amicus will be responsible to commercialize BMS's medicine portfolio, including innovative specialty-care products, in Hungary.

The amendment means that Amicus is now BMS's and UPSA's (the wholly-owned BMS affiliate) agent in the following countries: **Croatia, Estonia, Kosovo, Hungary, Latvia, Lithuania, Macedonia, Montenegro, Serbia and Slovenia.**

"This agreement will allow Amicus to expand its presence into Central Europe" Petr Nemeč, Board Member and co-founder of Amicus, commented. "We are honored that BMS chose to strengthen our partnership by selecting Amicus once more."
